### ALABAMA

Compliance Period: October 1 through September 30 of each year

Required Continuing Education: 10 hours per compliance period

The state of Alabama Board of Physical Therapy does not require pre-approval for continuing education activities. "All continuing education offerings, regardless of source will be accepted provided that it is directly related to the licensee's practice of physical therapy" and meets the general guidelines set forth by the board.

### ALASKA

Licensing Period: Two years, ending on June 30<sup>th</sup> of even numbered years.

Required Continuing Education: 24 contact hours for PTs licensed for 12 months or more of the concluding licensing period; 12 contact hours for PTs licensed for less than 12 months of the concluding licensing period.

- **All MAPS courses are pre-approved** as the State of Alaska Board of Physical Therapy & Occupational Therapy recognizes that MAPS has been approved by the New York State Education Department Board of Physical Therapy, as an authorized provider of continuing education for PTs and PTAs effective October 9, 2015 through October 8, 2018.

### ARIZONA

Compliance Period: Two years, September 1<sup>st</sup> of even-numbered years through August 31<sup>st</sup> of the following even-numbered year.

Required Continuing Education: 20 hours per two-year compliance period.

Arizona State Board of Physical Therapy recognizes activities as "Category A" if they have been approved by a national or state medical, PT, or health care association, or a component of the association **or** the FSBPT through ProCert. ## ARKANSAS

Licensing Period: Physical Therapists are required to renew their licenses annually by March 1st. Continuing Education must be obtained in the 24-months preceding the odd-numbered year renewal.

Continuing Education Requirements: Two (2) CEUs (20 contact hours) in the 24-months preceding the odd-numbered year renewal.

To receive CEU credit for a program, it must be approved by the Arkansas State Board of Physical Therapy or through ProCert.

## CALIFORNIA

Renewal Period: A license to practice physical therapy must be renewed every two years. The expiration date is the last day of the licensee's birth month during the second year of a two-year term.

Continuing Education Requirements: Continuing competency hours must be earned during the renewal period. For specific requirements please review the following information from the Physical Therapy Board of California's website:

(Physical Therapists and Physical Therapist Assistants are subject to the same continuing competency requirements)

**COLORADO**

Renewal Period: Two years, beginning November 1<sup>st</sup> of even-numbered years and ending on October 31<sup>st</sup> of the following even-numbered year.

Continuing Education Requirements: 30 contact hours per renewal period. Please review the following information from the Colorado State Board of Physical Therapy's Website for specific continuing education information: Continuing Professional Development (CPD) is the State Physical Therapy Board program through which a licensee can satisfy the continuing professional competency requirements in order to renew, reinstate, or reactivate a license. For each renewal period, the CPD program consists of the following elements:

1. A Reflective Self-Assessment Tool (RSAT) and establishment of learning goals;
2. Development of a Learning Plan;
3. Accrual of 30 points through Professional Development Activities (PDA). PDA are learning activities undertaken to increase a licensee's knowledge and skill or hone existing knowledge and skill for the purpose of continuing professional development. PDA are organized into Category I, II, and III activities with corresponding point values (refer to the Learning Plan and the Professional Development Activities (PDA) List). At least 15 points must be accrued from Category I activities; and
4. Once every 10 years, complete an Assessment of Knowledge and Skills (AKS), no more than two AKS will be credited in a 10 year period.

The Colorado Department of Regulatory Agencies State Physical Therapy Board does not preapprove specific courses or providers. A licensee shall determine which activities and topics will meet his/her Learning Plan and goals and select an appropriate provider.

## CONNECTICUT

*Licensing Period: 1 year (most licenses expire in the first birth month following insurance and are renewable annually thereafter.)*

*Continuing Education Requirements: 20 hours during the one-year period for which the license is being renewed.*

The Connecticut Board of Examiners for Physical Therapists does not approve continuing education courses or pre-approve specific coursework for individual licensees, nor does the Board maintain a list of continuing education courses. The law does not specifically identify qualifying continuing education course work.

## DELAWARE

*Licensing Period: Licenses expire on January 31 of odd years.*

*Continuing Education Requirements: 3.0 CEUs are required every biennial license renewal including 0.2 unites of ethics and 0.1 unit for a CPR course.*

The State of Delaware Examining Board of Physical Therapists and Athletic Trainers recognizes continuing education units that have been previous approved during the current licensing period by another agency such as a national governing body, for example, APTA and BOC, or a fellow state licensing board.

## DISTRICT OF COLUMBIA

*Licensing Period: Two-year period.*

*Continuing Education Requirements: 40 contact hours per two-year period. (Only 20 can be online/home study).*

The District of Columbia Board of Physical Therapy does not preapprove continuing education courses. ## FLORIDA

*Licensing Period: The biennium runs from 12/1/odd year-11/30/next odd year.*

*Continuing Education Requirements: Twenty-four (24) contact hours of continuing education must be completed within the current biennium for which the license is being renewed. A one hour HIV/AIDS course is required for first license renewal. Two hours on prevention of medical errors must be taken every renewal period. No more than 12 hours can be from home-study.*

The Florida Board of Physical Therapy recognizes courses approved by the American Physical Therapy Association (APTA), including other state APTA chapters and APTA sections, and, as a result, the following MAPS courses are recognized as approved by the FBPT:

## GEORGIA

*Licensing Period: Two-year period ending on December 31<sup>st</sup> of odd years.*

*Continuing Education Requirements: 30 contact hours required for each two-year licensure period. This must include 4 hours of ethics and jurisprudence.*

The Georgia State Board of Physical Therapy does not pre-approve any continuing education courses; however, there are courses offered by the programs identified in BR 490-4-.02 and Board Policy #7 which the Board will consider provided that the content beyond the licensee's present level of knowledge and competence which may be subject to audit by the board. Continuing education is reviewed on a case by case basis.

## HAWAII

*Licensing Period: Biennial ending December 31<sup>st</sup> every even numbered year.*

*Continuing Education Requirements: 30 CCUs per biennial. 1 CCU—at least 50 minutes of classroom or hands on instruction.*

The Hawaii Department of Commerce and Consumer Affairs Board of Physical Therapy accepts continued competence courses approved by the FSBPT's ProCert or by another state or jurisdiction's physical therapy board or its equivalent.

## ILLINOIS

*Continuing Education Requirements: 40 hours of continuing education prior to each renewal. At least 3 hours of the 40 hours must include content related to the ethical practice of physical therapy.*

The Illinois Department of Financial & Professional Regulation recognizes courses approved by the Illinois Physical Therapy Association and courses approved by the FSBPT's ProCert Program.
